## Client Bill of Rights

**Education and Training:** I was trained in hypnotism at the Paris VI university and at the Psychosomatic Medicine Institute of clinical hypnosis and brief therapy (Paris).

I was a physician in France (family doctor) and I did medical hypnosis. Continuing both hypnotism and general practice was a time consuming challenge, so I decided to stop practicing medicine in order to devote myself exclusively to hypnosis and thereby maintain my training at a high level. Since then I practice non medical hypnosis. I am no longer a licensed health care practitioner neither in France nor in the USA.

**Notice:** As the state of Michigan has NOT adopted educational and training standards for the practice of hypnotism, this statement of credentials is FOR INFORMATIONAL PURPOSES ONLY. Hypnotism is a self-regulating profession and its practitioners are not licensed by state governments. I may not provide a medical diagnosis nor recommend discontinuance of medically prescribed treatments. If a client desires a diagnosis or any other type of treatment from a different practitioner, the client may seek such services at any time. In the event my services are terminated by a client, the client has a right to coordinated transfer of services to another practitioner. A client has a right to refuse hypnotism services at any time. A client has a right to be free of physical, verbal or sexual abuse. A client has a right to know the expected duration of sessions, and may assert any right without retaliation.

**Ethics**: I practice in accordance with the <u>National Guild of Hypnotists's Code of Ethics and</u> <u>Standards.</u>

**Confidentiality**: I will not release any information to anyone without an authorization from you, except as provided for by law. You have a right to be allowed access to my written record about you.

**Fees**: The charge for my services are \$150 per consultation. The fees will stay the same during your hypnosis sessions block. If you miss 2 sessions, you'll be asked to pay full price in advance, non refundable.

**Insurance**: I don't take insurance. I suggest you think of my services as something that you will pay for personally. That will both protect your privacy and help you value the work you are doing more. In general insurance companies don't cover hypnotic services and I caution you not to expect them to do so. The fees can be adapted to your income, simply ask.

**My Approach**: Hypnotism is an effective and scientifically proven technique. The hypnosis technique that I practice is respectful of free will and therefore only works on clients wishing to do hypnosis. I value self empowerment, the client is always free and awake during all sessions. I suggest to also address the issues directly related to your reason for consultation: for example if you want to quit smoking but you can't because you gain weight as soon as you quit, we should work on weight loss too.
